## **PRODUCT DESCRIPTION**

Fresh Vegetables, Fruits & Flowers face mechanical and chemical damage after harvesting. KIF Kiffy pads are the right solution to protect fruits from physical damage and also slow the ripening process naturally.

Fruits start to ripen after harvesting and during the ripening process release ethylene gas and water vapour. This ethylene gas when in the package increases the ripening rate of the fresh produce hence aggravating the ripening process resulting into faster rotting of the fresh produce. The ethylene gas and water vapour produced work as catalyst to the ripening process which in turn causes faster spoilage and microbial damage.

Apart of ethylene damage growers, exporters, importers and suppliers also face major loses due to improper packing practices. Lack of proper cushioning or improper alignment of paper frills, fiber sheets and thermocol in fruit boxes impose pressure on fruits surface, because of this fruits get de-shaped and also causes several other issues in packed fruits like black patches, fruit damage and overall fruit spoilage.

Keep It fresh Kiffy Pads can be easily placed with fresh fruits & vegetables in trays, crates and boxes or in boxes placed one over another during shipment. The pads work in a multiple

ways to protect and extend shelf life of fresh produce.

KIF Series Solution is the most effective way to inhibit weight loss, deterioration, tenderness, color and taste change, pads are filled with power balls made with special composition mixture of zeolite powder and potassium permanganate in a fixed certain percentage that causes ethylene & moisture absorption and simultaneously causing volatile bacterial inhibition (VBI). Power balls are assimilated with fiber thread cushions and filled in pads. Ethylene causes shattering, deterioration and ripening on the other hand excess moisture is likely to speed up decay and the development of mould and fungus either during the storage/transportation period or after removal from the packaging.

Keep it fresh Pads forms a breathable membrane the moment it comes in contact with fresh fruits and vegetables. While cushion provides proper produce packaging and protects produce from damage. These can be easily placed with the fresh produce and absorb the ethylene gas and saves produce from damage due to pressure.


